# Week Four in the Legislature

- Gianforte's state of the state and Shannon O'Brien's rebuttal
  - The Gov: tax cuts (for the rich...), business, abortion, the southern border
  - o O'Brien: affordable housing, fair tax relief, education
- Stromswold's replacement appointed: Naarah Hastings
- Flament's replacement appointed: Ed Butcher
  - o Both seemingly hyper-conservative, culture-war type Republicans
- SB 121 tax cut bill, passed 2nd reading- would save top earners \$6k/year, and average Montanans \$50/year
- HB 303, Implement medical ethics and diversity act, scheduled for last minute hearing this morning in an attempt to limit opposing testimony

## SB-99, Provide for a youth health protection act

- Sen. Fuller's (R-Kalispell) anti-trans bill
- Hearing on Friday over 5 hours long
- Opponents greatly outnumbered proponents
- Testimony from medical professionals, educators, parents, trans youth
- Moving testimony from many, notably Rep. Zephyr
- Prognosis: will likely pass committee (Judiciary is stacked with anti-LGBTQ law makers), but passage by Senate unknown - similar bill failed in 2021

### Last Week's Action Alerts

- HB 252, Youth behavioral health screening
  - Karlen proposed clarifying amendment, still in committee
- HB 2, Funding for Childcare
  - Still in committee
- HB 2, Funding for Tribal Communities and Members
  - Still in committee
- SB 99, Provide for a youth health protection act
  - Still in committee
- HB 287 Revise laws related to Indian language preservation
  - Still in committee
- SB 154, Sen. Regier's bill claiming the right to privacy does not include abortion
  - Passed the Senate, transmitted to House
  - o Despite this, some R's recognized ridiculousness of this bill
    - McKamey "privacy is privacy, if enacted this bill would be unconstitutional"
- HB 152, Mercer's bill easing licensing restrictions
  - Passed Senate, transmitted to House


# Coming up: Montana Future Fund

OF THE WEEK

What: HB 280, Providing for circuit breaker income tax credit for property taxes paid

**Position: SUPPORT** 

When: Tuesday, January 31st @ 9 am

Where: House Taxation Committee - Room 152 - Sign up to testify or submit written comment

- Montana property taxes are too high for many Montanans, particularly affecting seniors on fixed income, but it's hitting every Montana homeowner in their pocketbooks
- A one time relief payment will only be a bandaid to the problem and won't do anything to stop Property Taxes to continue to grow
- This bill would provide ongoing protection against rising property tax bills for working Montanans by making sure that families' property tax bills never rise above a set percentage of their annual income (aka circuit breaker)

What: HB 285, Increase earned income tax credit and link to inflation

**Position: SUPPORT** 

When: Tuesday, January 31st @ 9 am

Where: House Taxation Committee - Room 152 - Sign up to testify or submit written comment

- This will put money back in working families' pockets
- Instead of big tax handouts that disproportionately benefit the wealthiest Montanans, the Earned Income Tax Credit (EITC) will ensure it is working people who will see the real benefits of tax relief and have the freedom to fully participate in our communities
- An increase in the EITC, means the difference between covering a surprise car repair and losing transportation to go to work, or affording health care in an emergency or going into debt
- Most importantly, this tax credit will rise as the cost of living does, to ensure that families' tax cuts don't get eaten away by inflation
- The Governor included EITC in his budget we're happy to see him include Democrat policies in his budget, but we don't think his EITC goes far enough, especially as the cost of living continues to rise.
- The Governor's giving thousands and thousands of dollars to the wealthy in the form of tax breaks. This bill will help ensure that working families will also see tax relief

What: HB 306, Require candidates for office be registered to vote

**Position: DO NOT SUPPORT** 

When: Tuesday, January 31st @ 9 am

Where: House State Administration Committee - Room 455 - Sign up to testify or submit written comment

**Goal:** 5+ in person/zoom, unlimited calls/emails

- This bill raises serious concerns about the possibility of \*who\* they could make ineligible to register to
  vote in the long run and how this could affect people's ability to run for office. If they continue to make it
  harder for some folks to register to vote, those same people will find it harder if not impossible to run for
  office
- Possibly unconstitutional as the Montana State Constitution AND the US Constitution expressly layout requirements for running for office
- This issue is top of mind because of Mallerie Stromswold's decision to resign. It's already difficult for people to run for office and serve as an elected official, there are a lot of ways that this bill could potentially bar underrepresented groups from serving in the future

What: HB 317, Provide for the Montana Indian Child Welfare Act

 Native american children deserve to be with their families, and in places that honor the unique values of the Indian child's tribal culture

What: **HB 201**, Revise minimum wage laws

**Position: SUPPORT**

Where: House Business and Labor Committee, Room 172 - Sign up to testify or submit written comment

**Goal:** 5+ in person/zoom, unlimited calls/emails to the committee

- The cost of everything, including, goods, services, and housing is skyrocketing in Montana
- Higher earnings will improve the overall standard of living and allow minimum wage workers to invest more of their earnings back into the economy and support local businesses as consumer spending will increase
- This minimum wage increase isn't extreme, but still provides a more propionate income level to handle the cost of living increases
- Raising the minimum wage will allow more families to move out of poverty and reduce the need for state and federal government assistance programs
- Sufficient wages spurs motivation in employees to put in their best effort on the job, and help increase employee retention
